

## **TERMS AND CONDITIONS FOR MS PLUS EVENTS (PHYSICAL AND VIRTUAL)**

To the fullest extent permissible under law, including the Australian Consumer Law (“ACL”) under Schedule 2 to the Competition and Consumer Act 2010 (Cth) these terms and conditions (“Terms”) govern all events (“MS Plus Event”) run and operated by MS Plus Ltd (Formally Multiple Sclerosis Limited) (ACN 004 942 287) (“MS Plus”) and each person (“Attendee, Participant, You or Your”) who registers to participate in an MS Plus Event or is invited by MS Plus to attend an MS Plus Event.

You acknowledge that You have read and agree to be bound by these Terms upon either submitting Your registration to MS Plus or attending or participating in an MS Plus Event.

If You intend on participating in an MS Plus Event and are under 18 years of age, a parent or guardian must read these Terms and acknowledge and accept them on Your behalf.

These Terms allow MS Plus to operate the MS Plus Event.

### **AUTHORITY TO REGISTER AND/OR TO ACT AS AGENT**

You represent and warrant to MS Plus that You have full legal authority and capacity to complete the registration for the MS Plus Event and accept these Terms, on behalf of yourself and/or, where applicable, any party for whom You are registering (the “Registered Parties”), including full authority to make use of the credit or debit card to which registration fees will be charged. As used in these Terms, “You” or “Your” means and includes You (as an individual) and all other Registered Parties for whom You are registering, and by virtue of agreeing to these Terms, for whom You are waiving certain rights.

### **1. REGISTRATIONS**

1.1 Your registration is subject to acceptance by MS Plus, which will be confirmed in writing (including but not limited to email) (“In Writing”) after MS Plus has received Your fully completed registration, including the entry form, the fee (if required) related to your registration (“Fee”) and any required supporting documents. MS Plus may in its absolute discretion for any reason refuse to accept Your registration.

1.2 MS Plus’s preferred method of registration is online. If You encounter difficulties with the online registration system, please contact MS Plus.

1.3 MS Plus may provide offline registrations via phone, email, or mail. MS Plus will use its best efforts to process offline registrations within two (2) working days of receipt.

1.4 If MS Plus has invited You to attend the MS Plus Event without the need to register and/or make any payment, You must provide Your confirmation of attendance to MS Plus within the time specified in the invitation (if any) in order for MS Plus to register You for the MS Plus Event.

1.5 The Fee for the MS Plus Event is correct at the time of publication. MS Plus reserves the right to change the Fee at any time but changes will not affect registrations which have already been confirmed In Writing by MS Plus.

1.6 By registering for an MS Event You consent to receiving and reading the information about the MS Event. If You have previously unsubscribed from MS Event communications, You will be re-subscribed upon

registration. MS Event communication will primarily be via email. Updated information will be posted on the MS Event website and through social media from time to time. It is Your responsibility to check the MS Event website to remain updated on MS Event communication.

## **2. CANCELLATION AND REFUNDS**

2.1 Fees are not refundable if You change your mind or are no longer able to participate in an MS Plus Event.

2.2 Fees will not be refunded if You are denied access or removed from an MS Plus Event for any reason.

2.3 A registration is not transferable to another person or to a future MS Plus Event without the express written permission or consent of MS Plus.

2.4 If You are inadvertently registered in an incorrect event (such as the Victorian event rather than New South Wales), MS Plus will aim to transfer your registration, however this will be dependent on capacity. You will be required to pay any difference in fees and MS Plus cannot change Your event options within the week prior to the MS Plus Event starting.

2.5 In the instance that MS Plus Event cannot proceed for any reason prior to commencement, Registered Parties will be offered the following options regarding the paid registration fee;

(a) convert the registration fee to a donation to MS Plus

(b) request a refund (issuable at MS Plus's discretion)

2.6 Options set out in paragraph 2.5 will be made available for a limited time. Registered Parties who do not indicate an option by the stated date will forfeit their right to receive this offer, including any possibility of receiving a refund.

2.7 If the MS Plus Event is cancelled after commencement, Registered Parties will not be offered a refund of the Fee. Cancellation may be for any reason including fire, traffic incident or weather.

2.8 All donations are non-refundable, including (but not limited to) in the event of cancellation, postponement or change of mind.

2.9 MS Plus is unable to transfer any donation to another participant or other MS Plus Event(s) (including future instalments of the same event).

## **3. MS PLUS'S RIGHTS**

3.1 MS Plus reserves the right at any time to:

(a) change the format, participants, content, location and timing or any other aspect of an MS Plus Event;

(b) postpone an MS Plus Event or any part of an MS Plus Event; or

(c) cancel an MS Plus Event or any part of an MS Plus Event, and will not be liable for any damages, costs, losses or expenses of any kind incurred or suffered by You as a result of or in relation to MS Plus modifying, postponing or cancelling an MS Plus Event or any part of an MS Plus Event.

#### **4. YOUR RIGHTS AND OBLIGATIONS AT AN MS PLUS EVENT**

4.1 MS Plus reserves the right, without any liability, to refuse admission to, or to eject You from an MS Plus Event, in its absolute discretion, including (without limitation), for failure to comply with these Terms or if in the opinion of MS Plus, acting reasonably, You represent a security risk, nuisance or annoyance to the running of an MS Plus Event.

4.2 You agree to comply with all reasonable instructions issued by MS Plus or the operator of the venue for an MS Plus Event.

4.3 All unauthorised photography and the recording or transmitting of audio or visual material, data or information is expressly prohibited at an MS Plus Event and/or in or at a venue.

4.4 You acknowledge that You may be filmed, sound recorded and/or photographed by MS Plus, the media or any other party at the Event and MS Plus may use or approve the use of the film, sound recording and/or photograph for any purpose and in any way whatsoever.

4.5 Excluding the MS Gong Ride, each participant is only eligible to claim one Fundraising Reward per event, which must be collected on Event Day. Your Fundraising Reward will be determined by the amount raised on Event Day. Eligibility is not transferable. Fundraising Rewards must be claimed on Event Day and cannot be swapped, exchanged or posted out after the event if they are not collected on Event Day or if a higher fundraising tier is later attained. Fundraising will remain open after the event; however, you will be rewarded for the fundraising tier you have reached upon Event Day. MS Plus reserves the right to supply an alternate Fundraising Reward of our choosing if stock runs out.

4.6 Fundraising Rewards for the MS Gong Ride are accumulative and can be claimed by YOU via your Fundraising Dashboard prior to the Event Day. Rewards will be posted out, and are also available for collection on the Event Day. MS Plus reserves the right to supply an alternate Fundraising Reward of our choosing if stock runs out.

#### **5. VIRTUAL AND OFF-SITE EVENTS**

5.1 For the avoidance of doubt, You acknowledge and agree that MS Plus will not be providing the usual scope of health and support measures including but not limited to road closures, first aid, mobile repair units or safety support during any off-site or Virtual MS Plus Event.

5.2 You acknowledge and agree that You remain at all times responsible for selecting a virtual course that is safe and complies with Your latest personal health advice as well as any broader advice or restrictions in relation to any Virtual MS Plus Event.

## **6. WELLBEING & SAFETY**

6.1 Children under 18 years of age must be accompanied by an adult for the duration of an MS Plus Event. For the MS Gong Ride, children under 12 years of age are not ordinarily eligible to participate and may only participate where MS Plus has given prior written approval and all additional conditions, declarations and waiver requirements imposed by MS Plus have been satisfied.

6.2 Subject to these Terms and applicable law, You are responsible for ensuring that You are medically and physically fit to participate and for acting safely and reasonably before, during and after any in person, remote, off-site, online or virtual MS Plus Event. If You are supervising a minor participant, You are also responsible for directly supervising that minor and for determining whether the minor is fit and suitable to participate. Nothing in these Terms excludes, limits or modifies any obligation owed by MS Plus under applicable law, including work health and safety legislation.

6.3 MS Plus recommends informing friends and family of Your intentions to participate and the details of any virtual or off-site route prior to participating in any MS Plus Event and You agree to carry out all reasonable and necessary precautions in relation to Your participating including but not limited to carrying a mobile phone, taking relevant medications and writing your emergency contact details down.

6.4 You should seek medical advice to ensure You and/or any supervised minor are fit to participate. It is Your responsibility to have suitable food and any medication that You require with You at all times.

6.5 First aid will be available at all in person MS Plus Events. Should You require ambulance transport to hospital it will be at your own expense.

6.6 You accept responsibility at all times for personal belongings during an MS Plus Event. Valuable items should not be left without supervision, as MS Plus will not accept liability for loss or damage of personal belongings.

6.7 In the likely event that equipment is used to participate in any MS Plus Event including but not limited to any equipment MS Plus notifies You is recommended, preferred or necessary for an MS Plus Event, You agree to ensure that any and all equipment is in good working condition, fit-for-purpose, properly maintained and meets all relevant safety requirements under applicable law.

## **7. LIMITATIONS OF LIABILITY AND INDEMNITY**

7.1 Relevant provisions of the Australian Consumer Law and other laws in force from time to time in Australia may impose guarantees, warranties, conditions and obligations on MS Plus (“Consumer Guarantees”). Nothing in these Terms excludes, restricts or modifies any right or remedy conferred on You by a Consumer Guarantee or any other right or remedy that cannot lawfully be excluded, restricted or modified.

7.2 To the extent permitted by law, including section 139A of the Competition and Consumer Act 2010 (Cth) and, where applicable, section 5N of the Civil Liability Act 2002 (NSW), liability arising from the supply of recreational services in connection with an MS Plus Event may be excluded, restricted or modified in relation to personal injury or death suffered as a result of participation in the MS Plus Event

7.3 Subject to clause 7.1 and to the extent permitted by law, MS Plus, its employees, agents, contractors, sub-contractors and volunteers will not be liable for any loss, damage, cost or expense arising out of or in connection with an MS Plus Event, except to the extent that such liability cannot lawfully be excluded, restricted or modified.

7.4 You acknowledge that involvement in an MS Plus Event may involve risks, including the risk of personal injury, illness, property damage or loss. To the extent permitted by law, You agree to indemnify and hold harmless MS Plus and its employees, agents, contractors, sub-contractors and volunteers against any claim, cost, demand, liability or damage (including reasonable legal costs) arising out of or in connection with: (a) Your breach of these Terms; (b) any negligent, reckless or unlawful act or omission by You; or (c) any loss of or damage to property, or injury to any person, caused by You.

## **8. MERCHANDISE**

8.1 MS Plus contracts various official merchandise providers for MS Plus Events.

8.2 Returns Policy - There are no refunds or exchanges on merchandise/apparel orders if You have simply changed your mind or chosen the wrong size, as all garments are made to order and are not kept in stock. MS Plus has a quality guarantee on all our garments. If the quality of the garment is defective, we can repair it, replace it or give You a full refund at our discretion. Simply email us at [orders@shop.ms.org.au](mailto:orders@shop.ms.org.au) and explain the nature of the defect and then send the item back to us within 7 days of receiving the garment in unworn condition and in its original packaging. You will bear the cost of returning the garment.

8.3 Delivery. From when you place your order until your garment is manufactured and ready for delivery, the process takes approximately six weeks. All parcels are sent via Australia Post (with tracking provided). Parcels will be delivered during normal business hours and can be delivered to Australian PO Boxes. Goods delivered within Australia will take 5-10 business days, from when you receive a shipping confirmation email from us but can be subject to Australia Post delays for which we cannot be held responsible. MS Plus and the contracted merchandise supplier(s) takes no responsibility for lost orders if incorrect address details have been provided. Please make sure Your shipping details are correct at the time of order.

## **9. TRAFFIC & ROAD LAWS**

9.1 Participants must follow all traffic and road laws including directions by Police, State or Territory Road Authority, Event Traffic Management, event staff and volunteers.

9.2 For cycling events participants must wear a cycling helmet that conforms to Australian standards.

## **10. INTELLECTUAL PROPERTY**

10.1 All material on an MS Plus Event website is protected by laws relating to intellectual property including but not limited to copyright, trademarks, designs, logos, signs, and other properties unless otherwise noted and may not be used except as expressly permitted by the applicable and relevant website terms and conditions. You may not distribute, modify or reuse the contents of any MS Plus Event web site for public or commercial purposes without the prior written permission of MS Plus.

## **11. PRIVACY AND ONLINE SECURITY**

11.1 MS Plus staff and volunteers understand and respect your right to privacy and the confidentiality and security of personal information provided by You. MS Plus will take all reasonable steps to ensure that Your personal information is protected from misuse, loss, interference and unauthorised access, modification or disclosure. You acknowledge that your personal information may be shared with others who are involved in the administration, management, insurance or delivery of the MS Plus Event. 11.2 All financial information pertaining to customers of MS Plus is stored securely in line with the Payment Card Industry Data Security Standards (PCI DSS), with no complete bank details retained. 13.1 MS Plus reserves the right to amend these Terms from time to time and You will be subject to the terms in force at the time MS Plus Registers You for an MS Plus Event or You attend the Event, if you do not need to Register, whichever is applicable. 13.2 Any failure, delay or relaxation on the part of a party in exercising, in part or whole, any power, right or remedy conferred upon that party by these Terms shall not operate as a waiver of that power, right or remedy.

13.3 If any provision of these Terms is invalid or not enforceable by a court of competent jurisdiction, the relevant term is to be read down and shall otherwise be capable of being severed to the extent of the invalidity or unenforceability without affecting the remaining provisions of these Terms

13.4 These Terms are governed by and are to be construed in accordance with the laws in force in Victoria. Each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of Victoria. For the avoidance of doubt, participation in an MS Plus Event conducted in another State or Territory remains

subject to any applicable laws, road rules, safety directions and regulatory requirements of that State or Territory
